

Banks Mill (University of Derby) Advent Prize Draws 2020

1. The prize draws are open to residents of England & Wales aged 18 years or over, except employees of the Promoter. Due to the nature of the prizes, entrants may need to be able to collect or take up their prize by attending in person at Banks Mill, 71 Bridge St, Derby DE1 3LB.
2. There are 23 separate daily prize draws during December 2020, the first takes place on 1st December and the last on 23rd December. Each daily prize draw is free to enter and no purchase is necessary.
3. Entry into all 23 daily prize draws is possible, to do this entrants will need to return to the website each day and submit a new entry form, entrants can enter up to 23 times, once for each daily prize draw.
